Terms and Conditions

General Conditions of Entry

1. These Terms and Conditions apply to the Autocare Convention Autodata Travel Voucher 9-10 June 2023 Promotion – promoted by Capricorn Society Limited (ACN 008 347 313) of 28 Troode Street, West Perth, Western Australia 6005 (the “**Promoter**”) in partnership with Autodata Australia Pty Ltd (ABN 47 109 278 766). 2. The Promotion runs for the duration of the Autocare Convention on 9-10 June 2023 (the “**Promotional Period**”) up until 3.55pm on June 10 with the draw to take place at 4pm.
3. Entry is open only to eligible Australian Members of Capricorn, being those businesses registered to conduct business in Australia that are Members of Capricorn and Australian trial members who are not yet shareholders during the Promotional Period and at the time of the prize draw. Employees and officers (and immediate family) of the Promoter or any related company are ineligible to enter.
4. There is one prize of a \$1000 Capricorn Travel voucher.
5. To receive an entry an eligible Member must sign up to an Autodata Diagnostic and Repair Plan during the promotional period at the 2023 Autocare Convention at the Brisbane Convention & Exhibition. Members who have already signed up to the Autodata Diagnostic and Repair Plan as at the commencement of the Promotion Period are ineligible. Each Member can have a maximum of one entry in the draw and the Authorised Representative who completed the sign up at the Convention is the “**Entrant**”
6. The Promoter in its sole and unfettered discretion will determine in the event of any uncertainty or dispute:
 - a. whether or not a business is an eligible Member;
 - b. whether or not an eligible Member is entitled to and entry.
7. The Promoter reserves the right, at any time, to verify the validity of entries and Entrants and reserves the right, in its sole discretion, to disqualify anyone who the Promoter has reason to believe has breached or does not comply with any of these Terms and Conditions, is not or has ceased to be an eligible Members or Entrant, tampered with the entry process or engaged in any unlawful or other improper misconduct calculated to jeopardise the fair and proper conduct of the Promotion. Failure by the Promoter to enforce any of its rights at any stage does not constitute a waiver of those rights.
8. If this Promotion is interfered with in any way or is not capable of being conducted as reasonably anticipated due to any reason beyond the reasonable control of the Promoter, including but not limited to technical difficulties, unauthorised intervention or fraud, the Promoter reserves the right, in its sole discretion, to the fullest extent permitted by law:
 - a. to disqualify any Entrant;
 - b. subject to any directions required from a regulatory authority, to modify, suspend, terminate or cancel the Promotion, as appropriate.
9. These terms and Conditions shall be governed by the laws of the State of Western Australia and of the Commonwealth of Australia and each Member agrees to submit to the exclusive jurisdiction of the courts thereof.

The Prize and Prize Draw

10. The prize draw will take place on June 10 at 4pm (AEST). All eligible entries received by the Promotor during the Promotional Period will be entered into the draw.
11. The draw will take place at the Autocare Convention at the Brisbane Convention & Exhibition Centre, Glenelg Street, South Brisbane, Queensland 4101. The draw will be from a random draw of all physical entries placed in the entry barrel and a single winning entry will be selected at random. The Promoter reserves the right to draw and record additional entries for use in the event that the initial entry is invalid or ineligible or the prize is unclaimed.
12. The Promotor's decision as to the winner is final and no correspondence will be entered into.
13. The prize is a \$1000 Capricorn Travel voucher awarded to the winning Entrant, with a validity period of 12 months from the date of the draw.
14. This Capricorn Travel Voucher (the "Voucher") is valid for any travel services offered by Capricorn Travel Australia Pty Ltd (ACN 008 926645) ("CTA") and purchased by or on behalf of or received by the recipient named on the Voucher.
15. The Entrants acknowledge and agree that CTA may refuse to redeem or accept if presented by, and to withhold services to, any person who cannot provide satisfactory proof of identity matching the Voucher recipient name on the Voucher or who is unable to quote the Voucher Reference Number.
16. The Voucher is not redeemable for cash and is non-refundable.
17. CTA shall not be liable for lost, stolen or damaged Vouchers.
18. Cash will not be given for any unused balance.
19. Subject to clause 20 below, if there is any credit remaining on redemption of this Voucher, the credit balance may be used towards future travel purchases with CTA until the credit balance reaches zero.
20. This Voucher is valid for travel taken before the expiry date detailed on the Voucher, which is the subject of a travel purchase with CTA, after which time the Voucher expires without compensation to any person including but not limited to the Voucher Recipient.
21. If the purchase with CTA exceeds the available Voucher balance, the Voucher recipient must make up the difference with another payment method accepted by CTA before being eligible to receive the purchased good(s) and/or service(s).
22. The value of the Voucher is in Australian dollars.
23. The usual terms and conditions of travel suppliers including but not limited to CTA will apply with respect to the travel services and will be unaffected by these Terms of Use.
24. Entrants agree that CTA has the right to amend the terms of use of the voucher at any time.
25. The Promotor may, in its discretion, substitute a prize or any part of a prize with a prize of equal value (subject to any direction or approval required from any relevant regulatory authority).
26. The winner will be informed by telephone or in person, and in writing (which may include by e-mail) within 7 days of the draw. The winner may claim the prize and will have it delivered to their preferred address via mail or via email as notified to Capricorn within 28 days of the draw. In the event that the winner chooses not to accept the prize, they forfeit all and any claims to the prize, and a winner will be redrawn under the clause dealing with an unclaimed prize.
27. Details of the winners may also be published in Capricorn Society Limited's trade publication *Ignition*, e-newsletters and social media channels and other publications.

Unclaimed Prize

28. If a prize is not accepted by a winner or it otherwise goes unclaimed for three months after the draw date, a redraw may take place on two business days after the prize is not accepted or otherwise goes unclaimed with notification of the winner and the timing for claiming and delivery of the prize otherwise occurring in accordance with the timing associated with the initial draw (subject to any direction or approval required from any relevant regulatory authority).

Promotional Activities

29. In the event that they are a winner, the Entrant consents to:
- a. participating in photo, recording or video sessions as reasonably required by the Promotion; and
 - b. the promoter using their name, likeness, image and/or voice (including photograph, film and/or recording of the same) in any media (including social media) and publications for an unlimited period without remuneration for the purpose of promoting this Promotion (including any outcome), the Promoter and any products arranged, distributed and/or supplied by the Promotor including Capricorn Service Data and Autodata.

Personal Information Collection Statement

30. The Promoter collects personal information in order to conduct the Promotion and may, for this purpose, disclose such personal information to third parties, including but not limited to agents, contractors, service providers, prize suppliers and, as required, to Australian regulatory authorities. Entry is conditional on this personal information being provided. The Promoter will also use and disclose personal information as set out in its Privacy Policy, which can be viewed at www.capricorn.coop. This includes using personal information for promotional, marketing, research and profiling purposes, including sending electronic messages or telephoning the Entrant. The Privacy Policy also contains information about how Entrants may opt out, access, update or correct their personal information, how Entrants may complain about a breach of the Australian Privacy Principles or any other applicable law and how those complaints will be dealt with. All entries become the property of the Promoter.
