# <u>Woolworths at Work & Capricorn – Two Easy Draw Promotion–</u> July to August 2025 – Terms and Conditions

## **General Conditions of Entry**

- These Terms and Conditions apply to the Woolworths at Work Two Easy Draw Promotion – promoted by Capricorn Society Limited (ACN 008 347 313) of Level 19, 141 St George's Tce, Perth WA 6000 (the "**Promoter**"). The Promoter can be contacted at the above address or by phone on 1800 327 437 or by email <u>csl@capricorn.coop</u>. Woolworths at Work refers to Woolworths Group Limited (88 000 014 675) of 1 Woolworths Way, Bella Vista, NSW 2153 ("**Woolworths at Work**").
- 2. The Promotion commences 12.01am AEST on 14 July 2025 and closes 11.59pm AEST on 15 August 2025 (the "**Promotional Period**").
- 3. Entry is open only to eligible Australian Members of Capricorn being those businesses registered to conduct business in Australia that are Members of Capricorn (including Australian trial members holding a Capricorn Trade Account), during the Promotional Period and at the time of the Prize Draw. Employees and officers (and immediate family) of the Promoter or any related company are ineligible to enter.
- 4. There will be one competition, with two winners drawn from a random draw (**Prize Draw**).
- 5. The competition prize for the Prize Draw is a \$750 credit on two winning Member's Capricorn Trade Accounts.
- 6. Eligible Members receive one entry to the Prize Draw if they make two purchases with a minimum spend of \$150 per purchase through Woolworths at Work on their Capricorn Trade Account during the Promotional Period. Purchase can be made in-store at Woolworths or online through Woolworths at Work. On receipt of an entry to the Prize Draw an eligible member becomes an "Entrant". Minimum spend of \$150 excludes purchases of tobacco and delivery fees.
- 7. The Promoter in its sole and unfettered discretion will determine in the event of any uncertainty or dispute whether or not a business is an eligible member.
- 8. The Promoter reserves the right, at any time, to verify the validity of entries and Entrants and reserves the right, in its sole discretion, to disqualify an Entrant who the Promoter has reason to believe has breached or does not comply with any of these Terms and Conditions, is not or has ceased to be an eligible member or Entrant, or has tampered with the entry process or engaged in any unlawful or other improper misconduct calculated to jeopardise the fair and proper conduct of the Promotion.
- 9. If the Promotion is interfered with in any way or is not capable of being conducted as reasonably anticipated due to any reason beyond the control of the Promoter, including but not limited to technical difficulties, unauthorised intervention or fraud, the Promoter reserves the right, in its sole discretion to the fullest extent permitted by law:
  - a. To disqualify any Entrant; and/or

- b. Subject to any directions required from a regulatory authority, to modify, suspend, terminate or cancel the Promotion, as appropriate.
- 10.Failure by the Promoter to enforce any of its rights at any stage does not constitute a waiver of those rights.
- 11. These Terms and Conditions shall be governed by the laws of the State of Western Australia and each Member agrees to submit to the exclusive jurisdiction of the courts thereof.

### **The Prize and Prize Draw**

- 12.The Prize Draw will take place at 10:00am AEST on 25 August 2025 at the offices of Woolworths at Work, 407 Elizabeth Street, Surry Hills, Sydney 2010. All eligible entries received by the Promoter during the Promotional Period will be entered into the draw.
- 13.The Prize Draw will be conducted by computer generation selection and one winning entry will be selected.
- 14. The Promoter reserves the right to draw and record additional entries for use in the event that the initial entry is invalid or ineligible or the prize is unclaimed. The Promoter's decision as to the winners is final and no correspondence will be entered into.
- 15. The total prize pool value is \$1500. The Promoter may, in its discretion, substitute a prize or any part of a prize with a prize of equal value (subject to any direction or approval required from any relevant regulatory authority).
- 16.The winner will be informed in email within 7 days of the draw. In the event that the winner chooses not to accept the prize or does not accept the prize within 28 days, they forfeit all and any claims to the prize.
- 17.Details of the winners may also be published in editions of Capricorn Society Limited's trade publication *Ignition*® and in any other media publications, promotional materials or social media accounts of the Promoter for a period of at least 28 days. By entering into the Prize Draw Entrants consent to their details being published as set out in this clause 20.

#### **Unclaimed Prize**

18.If a prize is not accepted by a winner or it otherwise goes unclaimed for two months after the Prize Draw date, the prize will be forfeit and there will be no redraw.

#### **Promotional Activities**

19.In the event that they are a winner, the Entrant consents to:

- a. Participating in photo, recording or video sessions as reasonably required by the Promoter; and
- b. The Promoter using their name, likeness, image and/or voice (including photograph, film and/or recording of the same) in any media for an unlimited period without remuneration for the purpose of promoting the Promoter and any products arranged, distributed and/or supplied by the Promoter.

#### **Personal Information**

a. The Promoter collects personal information in order to conduct the Promotion and may, for this purpose, disclose such personal information to third parties, including but not limited to agents, contractors, service providers, prize suppliers and, as required, to Australian regulatory authorities. Entry is conditional on this personal information being provided. The Promoter will also use and disclose personal information as set out in its Privacy Policy, which can be viewed at www.capricorn.coop. This includes using personal information for promotional, marketing, research and profiling purposes, including sending electronic messages or telephoning the Entrant. The Privacy Policy also contains information about how Entrants may opt out, access, update or correct their personal information, how Entrants may complain about a breach of the Australian Privacy Principles or any other applicable law and how those complaints will be dealt with. All entries become the property of the Promoter.
