## Woolworths at Work 2021 Holiday Hamper Promotion

### Terms and Conditions

#### General Conditions of Entry

1. These Terms and Conditions apply to the Woolworths at Work 2021 Promotion – promoted by Capricorn Society Limited (ACN 008 347 313) of 28 Troode Street, West Perth, Western Australia 6005 (the “**Promoter**”). The Promoter can be contacted at the above address or by phone on 1800 327 437 or by email at [csl@capricorn.coop](mailto:csl@capricorn.coop).
2. The Promotion commences on 12:01am AEST on 1 November 2021 and closes at 11:59pm AEST on 31 December 2021 (the “**Promotional Period**”).
3. Entry is open only to eligible members of Capricorn, being those businesses registered to conduct business in Australia that are members of Capricorn during the Promotional Period and at the time of the prize draw. Employees and officers (and immediate family) of the Promoter or any related company are ineligible to enter.
4. There are two **Prize Draws**:
  - a. **Prize Draw 1** will take place in December 2021.
  - b. **Prize Draw 2** will take place in January 2022.
5. Both Prize Draws are ‘Holiday Hampers’ valued at \$500 each. Each Hamper consists of a selection of Woolworths grocery items provided by Woolworths at Work.
6. Eligible Members receive one entry to the **Prize Draw 1** per every \$50 spent with Woolworths at Work on their Capricorn Trade Accounts during 1 November – 30 November (Inc GST, and any bagging and / or delivery charges). For entry, purchases must be received by the eligible member during the Promotional Period and will be reflected on the Member’s Capricorn Trade Account statements in November 2021.
7. Eligible Members receive one entry to the **Prize Draw 2** per every \$50 spent with Woolworths at Work on their Capricorn Trade Accounts during 1 December – 31 December (Inc GST, and any bagging and / or delivery charges). For entry, purchases must be received by the eligible member during the Promotional Period and will be reflected on the Member’s Capricorn Trade Account statements in December 2021.
8. There are no restrictions on how many entries an Entrant may receive to either Prize Draw.
9. The winner of Prize Draw 1 is not eligible for entry in Prize Draw 2.
10. The Promoter in its sole and unfettered discretion will determine in the event of any uncertainty or dispute:
  - c. whether or not a business is an eligible member;
  - d. whether or not an eligible member is an Entrant.
11. The Promoter reserves the right, at any time, to verify the validity of entries and Entrants and reserves the right, in its sole discretion, to disqualify anyone who the Promoter has reason to believe has breached or does not comply with any of these Terms and Conditions, is not or has ceased to be an eligible member or Entrant, tampered with the entry process or engaged in any unlawful or other improper misconduct calculated to jeopardise the fair and proper conduct of the Promotion. Failure by the Promoter to enforce any of its rights at any stage does not constitute a waiver of those rights.
12. If this Promotion is interfered with in any way or is not capable of being conducted as reasonably anticipated due to any reason beyond the reasonable control of the Promoter, including but not limited to technical difficulties, unauthorised intervention or fraud, the Promoter reserves the right, in its sole discretion, to the fullest extent permitted by law:
  - a. to disqualify any Entrant;
  - b. subject to any directions required from a regulatory authority, to modify, suspend, terminate or cancel the Promotion, as appropriate.

13. These Terms and Conditions shall be governed by the laws of the State of Western Australia and the Commonwealth of Australia and each Member agrees to submit to the exclusive jurisdiction of the courts thereof.

#### **The Prizes and Prize Draws**

14. The Prize Draw 1 will take place at 3:00pm AWST on 14 December 2021. All eligible entries received by the Promoter during the Promotional Period will be entered into the draw.

15. The Prize Draw 2 will take place at 3:00pm AWST on 11 January 2022. All eligible entries received by the Promoter during the Promotional Period will be entered into the draw.

16. Both Prize Draws draw will take place at the offices of the Promoter at 28 Troode St, West Perth, WA. The draws will be conducted by computer generated selection and a single winning entry per prize draw will be selected. The Promoter reserves the right to draw and record additional entries for use in the event that the initial entry is invalid or ineligible or the prize is unclaimed.

17. The Promoter's decision as to the winner is final and no correspondence will be entered into.

18. The prize for the winner of the Prize Draw will be provided as a physical gift hamper delivered to their business address within 4 weeks of the prize draw.

19. The total prize pool value is \$1,000. The Promoter may, in its discretion, substitute a prize or any part of a prize with a prize of equal value (subject to any direction or approval required from any relevant regulatory authority).

20. The winner will be informed by telephone or in person, and in writing (which may include by e-mail) within 7 days of the draw. In the event that the winner chooses not to accept the prize, they forfeit all and any claims to the prize, and a winner will be redrawn under the clause dealing with an unclaimed prize.

21. Details of the winners may also be published in the February 2022 edition and/or other editions of Capricorn Society Limited's trade publication *Ignition*®.

#### **Unclaimed Prize**

22. If a prize is not accepted by a winner or it otherwise goes unclaimed for three months after the draw date, a redraw may take place on two business days after the prize is not accepted or otherwise goes unclaimed with notification of the winner and the timing for claiming and delivery of the prize otherwise occurring in accordance with the timing associated with the initial draw (subject to any direction or approval required from any relevant regulatory authority).

#### **Promotional Activities**

23. In the event that they are a winner, the Entrant consents to:

- a. participating in photo, recording or video sessions as reasonably required by the Promoter; and
- b. the Promoter using their name, likeness, testimonial, image and/or voice (including photograph, film and/or recording of the same) in any media for an unlimited period without remuneration for the purpose of promoting Capricorn, the Promoter and any products arranged, distributed and/or supplied by the Promoter.

#### **Personal Information Collection Statement**

- a. The Promoter collects personal information in order to conduct the Promotion and may, for this purpose, disclose such personal information to third parties, including but not limited to agents, contractors, service providers, prize suppliers and, as required, to Australian regulatory authorities. Entry is conditional on this personal information being provided. The Promoter will also use and disclose personal information as set out in its Privacy Policy, which can be viewed at [www.capricorn.coop](http://www.capricorn.coop). This includes using personal information for promotional, marketing, research and profiling purposes, including sending electronic messages or telephoning the Entrant. The Privacy Policy also contains information about how Entrants may opt out, access, update or correct their personal information, how Entrants may complain about a breach of the Australian Privacy Principles or any other applicable law and how those complaints will be dealt with. All entries become the property of the Promoter.
