## **CAP ezi-parts - 50,000 Bonus Rewards Monthly Draw - October to December 2023**

### Terms and Conditions

1. These Terms and Conditions apply to the Capricorn 2023 CAP ezi-parts promotion— promoted by Capricorn Society Limited (ACN 008 347 313) of 28 Troode Street, West Perth, Western Australia 6005 (the “Promoter”) The Promoter can be contacted at the above address or by phone on 0800 401 444 or by email at [csl@capricorn.coop](mailto:csl@capricorn.coop).
2. The promotion is open to NZ Members only and runs from 1 October 2023 to 31 December 2023 (“Promotion Period”) and consists of 3 monthly prize draws with one 50,000 Bonus Rewards Points prize to be won each month.
3. The promotion is open to NZ Members who make a purchase on their Capricorn Trade Account using CAP ezi-parts during the Promotion Period (“Entrants”). An Entrant receives 1 entry per purchase made on the Capricorn Trade Account using CAP ezi-parts.
4. Members must purchase at least once in the month in order to go in the draw for the respective draw.
5. There are no restrictions on how many entries an entrant may receive for each monthly prize draw, however entries will be for one prize draw only, being the prize draw occurring in the month the relevant purchase was made.
6. The Promoter in its sole and unfettered discretion will determine in the event of any uncertainty or dispute:
  - a) whether or not a business is a Member eligible to enter the promotion; and
  - b) whether or not an eligible Member is an Entrant, including determining the date on which the purchase using CAP ezi-parts was made.
7. The Promoter reserves the right, at any time, to verify the validity of entries and reserves the right, in its sole discretion, to disqualify anyone who the Promoter has reason to believe has breached or does not comply with any of these Terms and Conditions, is not or has ceased to be an eligible Member or Entrant, tampered with the entry process or engaged in any unlawful or other improper misconduct calculated to jeopardise the fair and proper conduct of the Promotion. Failure by the Promoter to enforce any of its rights at any stage does not constitute a waiver of those rights.
8. If this Promotion is interfered with in any way or is not capable of being conducted as reasonably anticipated due to any reason beyond the reasonable control of the Promoter, including but not limited to technical difficulties, unauthorised intervention or fraud, the Promoter reserves the right, in its sole discretion, to the fullest extent permitted by law:
  - a) to disqualify any Entrant;
  - b) subject to any directions required from a regulatory authority, to modify, suspend, terminate or cancel the Promotion, as appropriate.
9. These terms and Conditions shall be governed by the laws of the State of Western Australia and of the Commonwealth of Australia and each Member agrees to submit to the exclusive jurisdiction of the courts thereof.

### **The Prize and Prize Draw**

10. The prize draws will take place on the third Monday of the of the following month at 10:30AM (AWST). All eligible entries received by the Promotor during the relevant month will be entered into corresponding monthly draw.
11. The draw will take place at the offices of the Capricorn Society, 28 Troode Street, West Perth, Perth WA 6005. The draw will be conducted by computer generated random number

generator selection and a single winning entry per prize draw will be selected at random. The Promoter reserves the right to draw and record additional entries for use in the event that the initial entry is invalid or ineligible or the prize is unclaimed.

12. The Promoters decision as to the winner is final and no correspondence will be entered into.
13. The prize for the three winners is 50,000 Bonus Rewards Points which will be added to their Capricorn Account.
14. The Promoter may, in its discretion, substitute a prize or any part of a prize with a prize of equal value (subject to any direction or approval required from any relevant regulatory authority).
15. The winner will be informed by telephone or in person, and in writing (which may include by e-mail) within 7 days of the draw. In the event that the winner chooses not to accept the prize, they forfeit all and any claims to the prize, and a winner will be redrawn under the clause dealing with an unclaimed prize.
16. Details of the winners may also be published in Capricorn Society Limited's trade publication Ignition, e-newsletters and social media channels and other publications.
17. All the usual terms and conditions applicable to the Capricorn Rewards Program will apply in relation to the prize. The Capricorn Rewards Terms and Conditions can be found at [www.capricorn.coop/tc](http://www.capricorn.coop/tc).

#### **Unclaimed Prize**

18. If a prize is not accepted by a winner or it otherwise goes unclaimed for three months after the draw date, a redraw may take place on two business days after the prize is not accepted or otherwise goes unclaimed with notification of the winner and the timing for claiming and delivery of the prize otherwise occurring in accordance with the timing associated with the initial draw (subject to any direction or approval required from any relevant regulatory authority).

#### **Promotional Activities**

19. In the event that they are a winner, the Entrant consents to: a) participating in photo, recording or video sessions as reasonably required by the Promotion; and b) the promoter using their name, likeness, image and/or voice (including photograph, film and/or recording of the same) in any media (including social media) and publications for an unlimited period without remuneration for the purpose of promoting this Promotion (including any outcome), the Promoter and any products arranged, distributed and/or supplied by the Promotor.

#### **Personal Information Collection Statement**

20. The Promoter collects personal information in order to conduct the Promotion and may, for this purpose, disclose such personal information to third parties, including but not limited to agents, contractors, service providers, prize suppliers and, as required, to relevant regulatory authorities. Entry is conditional on this personal information being provided. The Promoter will also use and disclose personal information as set out in its Privacy Policy, which can be viewed at [www.capricorn.coop](http://www.capricorn.coop). This includes using personal information for promotional, marketing, research and profiling purposes, including sending electronic messages or telephoning the Entrant. The Privacy Policy also contains information about how Entrants may opt out, access, update or correct their personal information, how Entrants may complain about a breach of the Australian Privacy Principles or any other

applicable law and how those complaints will be dealt with. All entries become the property of the Promoter
